# Amendment to Veterans' Support Regulations 2014: Statements of Principles and Accepted Late-Onset Conditions

Portfolio Veterans

On 28 March 2024, the Cabinet Legislation Committee:

- agreed that in accordance with section 23 of the Veterans' Support Act 2014, the Minister for Veterans (the Minister) has approved the revocation and replacement of 22 Statements of Principles, the revocation without replacement of two Statements of Principles, and the introduction of six new Statements of Principles relating to conditions that may be causally connected to a veteran's qualifying service;
- noted that the Minister has approved the revision of the name of one accepted late-onset condition set out in Schedule 2A of the Veterans' Support Regulations 2014 in order to align it with the Statements of Principles from which it was derived, and the addition of one condition to that Schedule;
- **noted** that the proposed changes are not expected to affect the overall Crown liability relating to veteran entitlements;
- 4 **noted** that in 2016, Cabinet authorised the Minister for Veterans to instruct the Parliamentary Counsel Office to amend Schedule 1 of the Veterans' Support Regulations 2014 to effect revisions to the Statements of Principles without further reference to Cabinet [CAB-16-MIN-0131];
- 5 **noted** that the proposed amendment of the Veterans' Support Regulations 2014 gives effect to the decisions referred to in paragraphs 1 and 2 above;
- 6 **noted** that the Veterans' Support Amendment Regulations 2024 come into force on 9 May 2024, thus complying with the 28-day rule;
- **authorised** the submission to the Executive Council of the Veterans' Support Amendment Regulations 2024 [PCO 26025/2.0].

# AMENDMENT TO VETERANS' SUPPORT REGULATIONS 2014: STATEMENTS OF PRINCIPLES AND ACCEPTED LATE-ONSET CONDITIONS

#### **Proposal**

- This paper seeks agreement to the amendment of Schedule 1 and Schedule 2A of the Veterans' Support Regulations 2014 (the Regulations).
- 2. This will assist Veterans Affairs in linking medical conditions with qualifying service for the purpose of entitlements.

#### **Background**

- 3. In deciding claims for entitlements Veterans' Affairs must assess whether a medical condition is linked to qualifying service. Statements of Principles are one of the mechanisms under the Act for establishing this link.
- 4. The Statements of Principles are determined by the Australian Government Repatriation Medical Authority (RMA). New Statements of Principles are introduced based on medical-scientific evidence linking the condition to service.
- 5. The Minister for Veterans Affairs must decide if any changes to the Statements of Principles should apply to New Zealand based on advice from Veterans' Affairs and the independent Veterans' Health Advisory Panel.
- 6. Cabinet previously authorised [CAB-16-MIN-0131] that the Minister for Veterans will issue instructions to the Parliamentary Counsel Office to draft amendments to Schedule 1 of the Regulations to effect revisions to the Statements of Principles unless a significant issue relating to the Statements of Principles revisions arises.
- 7. Accepted late-onset conditions is another mechanism for establishing a link between a veteran's service and their illness or injury and only applies to veterans whose qualifying operational service took place after 1 April 1974 (Scheme Two).
- 8. Its purpose was to ensure that families of veterans whose death was the result of a late-onset malignancy or other physical illness, or a mental disorder, receive entitlements under the Act.
- 9. The original list of accepted late-onset conditions was based on identifying which conditions were covered by Statements of Principles and then, of those, which had one or more late-onset causative factors.

#### **Proposed Regulatory Amendment to revise Statements of Principles**

- 10. None of the changes to Statements of Principles will make it significantly harder or easier to link a veteran's condition to service or are likely to result in significantly higher numbers of successful or failed claims.
- 11. In July 2023 and September 2023, Australia repealed and replaced 22 Statements of Principles. Veterans' Affairs have advised that this is suitable for use in New Zealand. The Statements of Principles in question are listed in Annex A.
- 12. The replacement Statements of Principles have undergone revisions, additions, and deletions of definitions, and of causative factors that link a veteran's injury, illness or

- death to their qualifying service; and in two cases a change to the names of the conditions (*Hodgkin's lymphoma* has changed to *Hodgkin lymphoma* and *Paget's disease of bone* has changed to *Paget disease of bone*).
- 13. The revocations of the two Statements of Principles for *intervertebral disc prolapse* are recommended for application in New Zealand as their content has been largely absorbed into the new Statements of Principles for *cervical intervertebral disc prolapse* and *thoracolumbar intervertebral disc prolapse*, with revisions to causative factors and definitions.
- 14. Accepted late-onset conditions are derived from the Statements of Principles. The list of these conditions first came into force in December 2015. The Statements of Principles for *Hodgkin's lymphoma* have been renamed *Hodgkin lymphoma*. Consequential amendment is needed in the list of accepted late-onset conditions.
- 15. Alignment of names of accepted late-onset conditions will not make it significantly harder or easier to link a veteran's condition to service or result in significantly higher numbers of successful or failed claims.
- 16. An annual audit has been conducted by Veterans' Affairs of the newly introduced Statements of Principles adopted in New Zealand since January 2023, and those which are listed in this submission and which will be adopted if Cabinet agrees. The purpose of the audit was to assess whether any of the conditions these Statements of Principles cover meet the criteria set out in section 7 of the Act for accepted late-onset conditions. Of the eight conditions covered by 16 new Statements of Principles adopted in New Zealand since January 2023, one condition portal vein thrombosis is recommended to be added to the list.
- 17. Portal vein thrombosis can be related to specific exposures or events during qualifying operational service that could result in a diagnosis of a malignancy, or other physical or psychological disorder, ten years or more after the qualifying service that subsequently causes the death of the veteran.
- 18. Any changes to a Statement of Principles, through amendment, revocation (repeal) or new introduction, and to the name of an accepted late-onset condition, and the addition of new accepted late-onset conditions, will not impact on any entitlement or service that has previously been granted under the Act.

#### Timing and 28-day rule

19. It is intended that the Veterans' Support Amendment Regulations 2024 will come into force on 9 May 2024, thus complying with the 28-day rule.

#### Compliance

- 20. The proposed amendment to the Regulations to replace Schedules 1 and 2A complies with each of the following:
  - 20.1. the principles of the Treaty of Waitangi;
  - 20.2. the rights and freedoms contained in the New Zealand Bill of Rights Act 1990 or the Human Rights Act 1993;
  - 20.3. the principles and guidelines set out in the Privacy Act 2020;
  - 20.4. the relevant international standards and obligations; and
  - 20.5. the Legislation Design and Advisory Committee Guidelines (2021) which are maintained by the Legislation Design and Advisory Committee.

21. In accordance with section 23 of the Act, before reaching my decision that the 22 Statements of Principles should be revoked and replaced, and six newly introduced Statements of Principles should be adopted, I received reports from Veterans' Affairs and independent advice from the Veterans' Health Advisory Panel. Both recommended the adoption of the proposed changes. I also received a report from Veterans' Affairs on the proposed addition of one condition (portal vein thrombosis) to Schedule 2A List of accepted late-onset conditions.

#### **Regulations Review Committee**

22. There are no grounds for the Regulations Review Committee to draw this regulation amendment to the attention of the House under Standing Order 327.

#### **Certification by Parliamentary Counsel**

23. The draft Amendment Regulations have been certified by the Parliamentary Counsel Office as being in order for submission to Cabinet.

#### **Financial Implications**

24. These changes are not expected to affect the overall Crown liability relating to veteran entitlements.

#### **Impact Analysis**

25. The Regulatory Impact Analysis Team at the Treasury has determined that the regulatory proposals in this paper are exempt from the requirement to provide a Regulatory Impact Statement on the basis that they have no, or minor, impacts on businesses, individuals or not-for-profit entities.

#### **Publicity**

26. Veterans' Affairs will publish the changes on its website.

#### **Proactive Release**

27. I intend to release this paper in full apart from any legally privileged material.

#### Consultation

28. The Treasury was consulted in the course of developing the policy and the amended Schedules 1 and 2A of the Regulations.

#### Recommendations

- 29. I recommend that the Cabinet Legislation Committee:
  - 1. Agree that in accordance with section 23 of the Veterans' Support Act 2014, I have approved the revocation and replacement of 22 Statements of Principles, the revocation without replacement of two Statements of Principles, and the introduction of six new Statements of Principles relating to conditions that may be causally connected to a veteran's qualifying service.
  - 2. **Note** that I have approved revision of the name of one accepted late-onset condition set out in Schedule 2A of the Veterans' Support Regulations 2014 in order to align it with the Statements of Principles from which it was derived, and the addition of one condition to that Schedule.
  - 3. **Note** that the proposed changes are not expected to affect the overall Crown liability relating to veteran entitlements.

- 4. **Note** that Cabinet authorised [CAB-16-MIN-0131] the Minister for Veterans to instruct the Parliamentary Counsel Office to amend Schedule 1 of the Veterans' Support Regulations 2014 to effect revisions to the Statements of Principles without further reference to the then Cabinet Social Policy Committee.
- 5. **Note** that the proposed amendment of the Veterans' Support Regulations 2014 gives effect to the decisions referred to in recommendations 1 and 2 above.
- 6. **Agree** that the Veterans' Support Amendment Regulations 2024 will come into force on 9 May 2024, thus complying with the 28-day rule.
- 7. **Authorise** the submission to the Executive Council of the Veterans' Support Amendment Regulations 2024.

### **Explanatory note**

This note is not part of the regulations but is intended to indicate their general effect.

These regulations, which come into force on 9 May 2024, amend the Veterans' Support Regulations 2014 (the **principal regulations**).

Regulation 4 and Schedule 1 amend Schedule 1 of the principal regulations, which lists the Australian statements of principles (the **statements**) that apply to specific medical conditions for the purposes of the Veterans' Support Act 2014 (the **Act**). The amendments—

- insert the names of 3 new conditions and references to statements related to those conditions:
- replace the names and references to statements of 2 conditions in order to reflect the updated statements:
- revoke the name and references to statements of intervertebral disc prolapse, as
  the content of the statements has been largely absorbed into the new statements
  of principles for cervical intervertebral disc prolapse and thoracolumbar intervertebral disc prolapse:
- replace references to certain statements with updated references.

Regulation 5 and Schedule 2 amend Schedule 2A of the principal regulations, which lists accepted late-onset conditions for the purposes of the definition of accepted late-onset condition in section 7 of the Act. The amendments—

- insert the name of 1 new condition and references to statements related to that condition:
- replace the name of 1 condition in order to reflect the updated statements.

Issued under the authority of the Legislation Act 2019.

Date of notification in Gazette:

These regulations are administered by the New Zealand Defence Force.
