I refer to your email of 28 March 2023 requesting, under the Official Information Act 1982 (OIA), information about arrests made by the New Zealand Defence Force (NZDF) Military Police.

*The total number of arrests made by military police in New Zealand in the past year.*

*A breakdown of the types of offenses that resulted in these arrests.*

*The locations where these arrests took place.*

*I would appreciate it if you could provide any relevant documents or correspondence related to this request.*

NZDF Military Police made eight arrests between 25 March 2022 and 28 March 2023. The below table sets out the location and charge for each arrest. Note that while the NZDF Military Police operate across NZDF Camps and Bases, all arrests between 25 March 2022 and 28 March 2023 occurred in relation to NZDF personnel based at Linton Army Camp. Two arrests are still under investigation. The reports related to the six completed investigations are enclosed with redactions in accordance with section 9(2)(a) of the OIA to protect the privacy of individuals.

At 50a Princess Street Palmerston North, on 7 May 22, about 0303 hours, MP arrested O1 for using a class B substance namely MDMA.

0245 hours MP1 and MP2 were conducting a 3W IVO The Daily Bar on Berrymans Lane, Palmerston North CBD.

Whilst there MP1 and MP2 observed O2 being kicked out of The Daily Bar by security staff for using MDMA. O1 followed O2 out of the club and down Berrymans Lane towards Main Street, turning left onto Main Street and walking towards Princess Street.

MP1 and MP2 followed O1 and O2 IOT question O1 IRT his association with O2.

MP2 stopped O1 outside 50a Princess Street, Palmerston North, and began 4Q with O1 IRT O2.

Whilst this was occurring NZ Police 10/7 P, POC is listed as W. W dealt with O2 and eventually arrested him for possession of MDMA. W remained present whilst MP2 and MP1 dealt with O1.

0302 hours MP2 asked O1 "Have you had MDMA this evening?"

O1 answered "Yes".

0303 hours MP2 placed O1 under arrest for taking MDMA. O1 was afforded his BoR and Caution and placed into mechanical restraints.

0310 hours MP2 commenced ROI with O1.

0320 hours MP2 concluded ROI with O1 due to lack of O1 interaction and belligerent behaviour.

0325 hours MP1 conducted a body search of O1 before placing him in the back seat of U1. Nothing was found on O1 other than his personal belongings.

0332 hours 10/2 LMC Cells.

0335 hours MP2 contacted CO RRNZA.

CO RRNZA granted MP2 verbal permission to conduct a reasonable cause UT under caution on O1.

0337 hours RSM RRNZA requested piquets.

0347 hours 10/7 LMC Cells.

0355 hours MP1 conducted body search of O1 in the LMC Cells staging area. All personal items were removed, MP3 commenced PRS of items.

0403 hours UT brief given to O1 witnessed by MP2.

0407 hours UT commenced.

0415 hours O1 UT result showed Not NEG for MET and AMP. O1 witnessed and signed UT combined Chain of Custody form. MP2 took photo of UT itself.

0425 hours MP1 commenced specimen extraction process to be sent away to ESR for confirmatory testing. Witnessed by W1, W2 and O1.

0440 hours ESR specimen packaged and sealed by MP1, witnessed by W1, W2 and O1

0421 hours O1 was placed into Cell 1 by MP2.

0444 hours MP3 completed PRS.

0454 hours MP2 completed Committal Receipt, HOTO with WO2 [REDACTED], [REDACTED], 16 FD, 163 BTY. 0500 hours MP1, 2, 3, K6 10/3
