

The national Radio Spectrum Management (RSM) radio investigation team is looking into several interference reports from Wireless ISP (WISPs) providers in Taranaki, Manawatu, Nelson and Marlborough and have contacted us as they believe the interference could be coming from the visiting ship HMAS Canberra.

The WISPs reporting the interference operate in the 5 GHz band mainly between 5.7 - 5.9 GHz. RSM suspect it is interference from HMAS Canberra **s.** 6(a)

making it a likely candidate as

the source of the interference.

Further to this, <u>final</u> MBIE response below, slightly modified from the earlier response. They have advised their Minister's Office.

This can be attributed to Claire Smollett, National Manager, Radio Spectrum Management:

We were made aware of an issue affecting wireless internet service providers in the Marlborough region on the morning of 4 June 2025. Following this, Radio Spectrum Management notified the New Zealand Defence Force (NZDF) that we believed a Royal Australian Navy ship, HMAS Canberra located in Cloudy Bay, Marlborough, was causing issues to operators of wireless internet providers in that region. We have contacted NZDF about this issue. Following that, we have received no further reports of interference.

Regarding Mr Brewer's claims on LinkedIn, we currently have no evidence to confirm how widespread the interference was.

We take all interference matters seriously, especially those that cause widespread issues. As we have no further information at this time, we are unable to comment further.

The RSM radio investigation team is looking into several interference reports from Wireless ISP (WISPs) providers ranging from Taranaki to Marlborough. These WISPs operate in the high end of the 5 GHz band between 5.7 – 5.9 GHz (5GHz WiFi is also in there). They suspect it is interference from the ship s. 6(a)

ETA Wellington tomorrow morning. s. 6(a)

making it a likely candidate as the source of the interference.

My COA is to reach out to my counterparts s. 6(a)

and ask them to get a message to

HMAS Canberra, informing them of the interference reports, s. 6(a)

and asking

them to cease any transmissions that cover the 5.7 - 5.9 GHz band whilst in NZ territory, unless JFNZ want to take the lead on doing this **s**. **6(a)**
