0014 hrs At Linton Military Police Station, Linton Military Camp, Palmerston North, on the 4 August (September [REDACTED] 2021, about 0014 hours, MP 1 received a noise complaint from a female, behide the back gate of Linton Military Police Station.

0016 hrs MP 1 and MP 2 conducted a foot patrol in the vicinity of D'arcy Barrack, Linton Military Camp, Palmerston North.

0018 hrs MP 2 observed S1 intoxicated, aggravated, shirtless and held down by two individuals.

0020 hrs MP 1 was informed by C1 that she been dragged by S1.

0023 hrs S1 was placed in handcuffs and detained for acting disorderly and to prevent further offending by MP 2.

0220 hrs MP 1, MP 2 and S1 arrived at Ohakea Military Police Station.

0225 hrs MP 1 conducted a search of S1 before placing S1 into the cell. No items of interest were found. S1 personal items were PRS and put into a bag.

0233 hrs S1 was placed into Ohakea cells.

0259 hrs Unit Picquets arrived for S1.

0301 hrs MP 2 conducted a handover to CPL [REDACTED], 1RNZIR who was tasked as Guard Commander of S1.

0310 hrs MP 2 handed custody of S1 to CPL [REDACTED].

0317 hrs S1 personal belongings were signed over to CPL [REDACTED]

0343 hrs MP 2 woke up S1 and asked if he would like to speak to a lawyer. S1 informed him he did not.
