I refer to your email of 24 December 2025 requesting, under the Official Information Act 1982 (OIA), information related to your previous request 'on the subject of silencers not accounted for' (OIA-2025-5387). Specifically, you have asked for:

- *All communications between 1NZSAS Regiment and the Joint Military Police Unit relating to the silencers, from February 2020 onwards;*
- *All communications on the subject between the JMPU and NZ Police;*
- *All communication on the issue between JMPU and other parts of the Defence Force.*

Enclosed is a copy of relevant communications. As noted in the email of 13 February 2026, where indicated information is withheld to: avoid prejudice to the security and defence of New Zealand in accordance with section 6(a) of the Official Information Act 1982 (OIA); protect privacy in accordance with section 9(2)(a) of the OIA; and, avoid malicious or inappropriate use of internal information in accordance with section 9(2)(k) of the OIA.

Good morning Sir,

Have you received a reply back reference the below email? If not please let me know.

A bit of context behind this, TG6 alerted JMPU in 2020 of a collection of missing items including the suppressors as a result of a stores check, however they were informed to conduct 100% check and once completed they were to return to JMPU confirming exactly what missing so we could initiate the report.

The final return was not provided as a result a JMPU Report was not initiated at the time. After the RFI earlier last month, I was provided the report for the Write Off of Stores confirming items that were missing including the initial suppressors. I have been told that since then 3 of the suppressors have been located also.

The file number for this is 202505210001 and the items also reported to the NZP whom also provided s. 9(2)(k) No investigation into the missing items were conducted as the items have since been written off and the time in which the items went missing could not be determined as the list provided was over a space of so many years and TG6 had completed their own internal report into the missing items in total.

I have spoken to s. 9(2)(a) COS DLC whom had been tasked with the RFI originally and informed him of the background reference this also.

Hey s. 6(a)

In Feb 2020, s. 6(a) reported to PAP MP that stores items were missing (missing between 2018 - 2020), he was requested by MP to conduct an internal check/investigation and confirm the items missing and then lodge a complaint. This is standard request from MP as we receive many of these stores accounting reports weekly and often the items are found in a store or there is some form of SAP error identified.

From an MP perspective, a comprehensive list of missing items and the timeframes over which they were deemed as missing needed to be confirmed IOT to conduct a preliminary investigation. It appears s. 6(a) did not come back to PAP MP with that information and therefore no MP report was generated at that time.

s. 6(a) contacted MP again in May 2025 IRT this matter, a file number was generated (202505210001) and the A Class Stores were reported as missing, and IAW with the reporting requirements for A class stores the loss was reported to NZ POL.

The JPMU file number for the investigation of the TG6 loss of stores (including the 6 x suppressors) is s. 9(2)(k). The investigation was inconclusive though as some of the items were identified as having been missing/unaccounted for/lost for years. There is also the possibility that they were damaged beyond economic repair (BER) at some point or unserviceable, and written off, but the paperwork did not follow through.

I have to respond to an OIA request regarding a number of suppressors that went missing between 2017 and 2019.

My contacts in DEMO have requested the MP reports from an investigation but have not received a response – the OIA is **due to CJDS today**.

The details of the suppressors are as follows and I would appreciate it if you could hasten the report or confirm that no document exists.

The 6 x Suppressors (Surefire SOCOM556-RC-BK) were, between 2017 and 2019, unable to be located in stock-checks. An MP investigation was initiated from which nothing eventuated. Subsequent to this investigation, three of the suppressors were found and bought back onto charge. The other three were not found and were written off as shown in the attached document. The table below identifies the details of the suppressors and the
